7. ANNOUNCEMENT OF FTA FY18 - 5310 GRANTS

8. DISCUSSION AND POSSIBLE ACTION TO AMEND FY16-25 METROPOLITAN TRANSPORTATION IMPROVE PLAN (MTIP) TO ADD FY18 TRANSIT GRANT RECIPIENTS

Vincent Gallegos, CYMPO Transportation Planner (Task #200)

Mr. Gallegos informed the Executive Board that upon notification of who will receive FY18 5310 grants, those amounts must be shown in CYMPO's MTIP. Mr. Gallegos then informed who made application, the amounts and purposes of the grants:

- CYMPO Mobility Management \$90,000 plus local match of \$22,500
- New Horizons Operating Award \$90,000 plus local match of \$90,000
- New Horizons Capital \$39,400 plus local match of \$10,400
- New Horizons Mobility Management \$61,000 plus local match of \$15,200

Secretary/Treasurer Orr presented a motion to amend the FY16-25 MTIP to include ADOT FY18 Transit Grants as presented. The motion was seconded by Member Nolan.

9. DISCUSSION, UPDATE AND POSSIBLE ACTION ON STATE TRANSPORTATION BOARD ACTIVITIES

Chris Bridges, CYMPO Administrator (Task #102)

Mr. Bridges, CYMPO Administrator, informed the Executive Board that all signatures have been obtained from Yavapai County and the City of Prescott to finalize the JPA with ADOT for the design of the SR69 widening project. This project was NOT added to the 5-year construction plan adopted the State Transportation Board in June. However, one of the STB Board members asked that SR69 be added as a Specific Agenda item in July to discuss SR69 improvements. Mr. Bridges announced he would be attending that meeting and offered a ride to any Board Member who also wanted to attend.

10. DISCUSSION AND POSSIBLE ACTION TO APPROVE A RESOLUTION IN SUPPORT OF ADOT SEEKING ALTERNATE FUNDING SOURCES FOR INTERSTATE 15 (I-15) TRANSPORTATION ROADWAY IMPROVEMENTS

Chris Bridges, CYMPO Administrator (Task #102)

CYMPO Chairman Brown read the Resolution to the audience. He further explained that I-15 is a small strip of interstate between Arizona, Utah and Nevada which contains several bridges. This stretch of interstate is in need of major repairs which would drain ADOT of funds important to local projects. CYMPO and other MPO's in the state of Arizona will be submitting similar resolutions to ADOT requesting ADOT to seek alternative funding to minimalize the negative impact of funding allocated to the remainder of Arizona.

Chris Bridges, CYMPO Administrator informed the board the Sun Corridor was urged to initiate this Resolution. The concern is there are six bridges in this 29-mile stretch of I-15 that are in need of repair and/or replacement. To do the necessary repairs would totally exhaust ALL of ADOT's funding for the rest of the state.

MOTION

Chairman Brown presented a motion to authorize the Chair, or in his absence the Vice-Chair, the signing of Resolution 2017-02 in support of ADOT seeking alternative funding sources for the Interstate 15 (I-15) transportation roadway improvements. The motion was seconded by Member Nolan.

VOTE ON THE MOTION

The vote on the motion was unanimous.

11. DISCUSSION AND POSSIBLE ACTION TO ESTABLISH AN ECOSYSTEM CONNECTIVITY ADVISORY COMMITTEE (EMAC)

During the June TAC meeting there was lengthy discussion regarding the establishment of an Environment and Land Use Advisory Committee. Presented to the TAC was the below information regarding their purpose,

membership, structure and scope. The TAC asked for one modification and that was the reporting to the TAC and/or the Executive Board would be done on an "as needed" basis rather than monthly.

Name:

 Title for the group would be "Ecosystem Connectivity and Mitigation Advisory Committee" could be called EMAC for short

Purpose:

 The mission of the EMAC is to study and advocate for the preservation of interconnected ecosystems in the CYMPO Region that will integrate land use and mitigation for natural resource protection, and wildlife habitats into the regional transportation planning and design program.

Membership:

- 7 voting members with additional participation as needed.
 - ADOT NW District Environmental
 - o AZ G&F
 - Yavapai County Land Use Planning Staff
 - Prescott National Forest
 - o 3 Private Citizens (Must reside in CYMPO Planning Boundary)

Structure:

- Stand Alone Committee- Reporting to the TAC and the Executive Board on an-as needed basis.
- There would <u>not</u> be a seat on the TAC from this committee
- Committee would be able to pursue other grant funding to add to the current transportation funding CYMPO receives

Scope:

- Participate in Regional Planning and Design Studies performed by CYMPO, ADOT and Local Public Agencies
 - o Make recommendations to TAC during the planning or design phases of projects
- Coordinate and Participate in regional ecosystem connectivity and mitigation planning studies (Funded by FHWA or other grants)
- Pursue funding opportunities for ecosystem connectivity and mitigation through FHWA, existing 501.c.3 organizations, or other sources
- Coordinate with Local Public Agency Land Use Planning Staff to coordinate Land Use and Transportation and EMAC issues
- Provide EMAC related education for Executive Board, TAC and public

MOTION

Chairman Brown presented a motion to approve the establishment of the Ecosystem Connectivity and Mitigation Advisory Committee (EMAC) as an advisory committee to the CYMPO TAC and Executive Board. The motion was seconded by Member Nolan.

VOTE ON THE MOTION

The vote on the motion was unanimous.

12. DISCUSSION AND POSSIBLE ACTION TO AMEND CURRENT BY-LAWS

Mr. Bridges informed, with the approval of the above mentioned committee, it is necessary to amend CYMPO's By-Laws. The Technical Advisory Committee discussed cleaning up the language specifically regarding the

13. DISCUSSION AND POSSIBLE AUTHORIZE SIGNATURE OF THE JOINT PROJECT AGREEMENT (JPA) 11-087 AMENDMENT SEVENBETWEEN THE STATE OF ARIZONA – ADOT AND CYMPO

Mr. Bridges stated this JPA is currently being reviewed by ADOT attorneys. Once finalized CYMPO will submit to our attorney for review. It is possible for this to take place prior to the next Executive Board meeting and he was seeking advance approval for the CYMPO Chair's signature on the JPA to permit a quick turn-around back to ADOT.

Secretary/Treasurer Orr presented a motion to authorize the CYMPO Chair, or in his absence the Vice-Chair, to sign JPA 11-087 Amendment Seven once finalized by ADOT and approved by CYMPO attorney. The motion was seconded by Secretary/Treasurer Nolan.

14. DISCUSSION AND POSSIBLE ACTION TO SIGN CYMPO'S RENEWAL OF LEASE AGREEMENT WITH YAVAPAI COUNTY
