# 5. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE FY15-24 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM (MTIP)

Chris Bridges, CYMPO Administrator (Task #3.0)

Mr. Bridges explained minor changes made to the MTIP, but this is the same basic document the TAC made recommendation for your approval at their last meeting.

# **MOTION**

Secretary Treasurer Nolan presented a motion to approve the final draft of the FY15-24 Metropolitan Transportation Improvement Program (MTIP). The motion was seconded by Member Croft.

### 6. DISCUSSION OF NAIPTA PARTNERSHIP

Chris Bridges, CYMPO Administrator (Task #8.0)

Mr. Bridges provided background: CYMPO is designated to receive approximately \$1.1 Million 5307 funding for transit operations annually which has been turned back to ADOT for distribution, on a competitive basis, to other transit operations within the State. Currently, Yavapai Regional Transit operates a rural public transit system in our area. They provide regional service between Chino Valley and Prescott. YRT would like to expand to Prescott Valley but does not have the funding. It was explained to ADOT CYMPO was not able to provide the local match required to access 5307 funds, would it be possible to partner with NAIPTA, Northern Arizona Intergovernmental Public Transportation Authority, in such a way as NAIPTA would provide the required match, keep a portion of the funds for their use and distribute the balance to YRT thereby giving YRT a sustainable source of income and professional assistance necessary to expand into Prescott Valley. Mr. Bridges then asked if the Executive Board and TAC would consider this possibility and like for him to pursue more information.

CYMPO M-TAC member Byron Jaspers clarified, should Yavapai County join NAIPTA it would allow CYMPO to partner with NAIPTA and access 5307 funds. Furthermore, YRT is the only regional public transit provider currently in our region. They are not being favored, just the only game in town.

At the last meeting with NAIPTA, Mr. Bridges explained, there was discussion to begin with a multiple year contract, with an option to opt out or continue on at the end of the contract.

Member Brown agreed this would give YRT the ability to make long range plans for expansion.

Mr. Bridges stated, until recently Yavapai County was a member of NAIPTA and there were questions about why the agreement was discontinued. He met with Cottonwood Transit Director who advised, CATS came to a point where they had grown enough they could operate system without assistance from NAIPTA.

Mike Normand, ADOT's Transit Division Manager advised Mr. Bridges, joining NAIPTA is probably the only way ADOT would support the returning of 5307 funds to CYMPO.

Member Croft requested a cost benefit analysis be provided.

Ron Romley, Yavapai Regional Transit, provided an update of YRT's ridership. He stated NAITPA has the ability to purchase more than one bus per year and would provide expertise in route management, expansion and equipment.

Sandy Stutey commented on the value in partnering with NAIPTA.

Mr. Bridges again asked for direction.

Consensus from the M-TAC and Executive Board was given to move forward with NAIPTA negotiations.

# 7. DISCUSSION AND UPDATE ON SR89A CORRIDOR DEVELOPMENTS

Chris Bridges, CYMPO Administrator (Task #1.2)

Mr. Bridges opened the discussion by stating this topic was at the request of a Board Member at the last meeting. Our community is seeing a lot of development from Willow Creek and the Airport area all the way along the SR89A corridor. The RTP will include traffic models reflective of this growth, but we do not have enough information to know what those impacts will be until those traffic models are done.

M-TAC Chairman, Scot Tkach, offered information regarding the Granite Dells Development and Executive Board Proxy Member, Lora Lee Nye, offered information on the Glassford Heights Development.

Thomas Slayback, of the Prescott Sierra Club, commented he would like the 89A corridor plan include both bicycle and pedestrian facilities for commuting.
