Norm Davis presented letter from Prescott Valley Mayor regarding Robert Road/SR 89A intersection. Letter was read aloud by Chairman Brown. Mr. Davis explained that fatality rate of Robert Road/SR 89A is twice what would be expected and requested the Executive Board reconsider the priority placement of improving the intersection on the MTIP.

# 8. REVIEW, DISCUSSION AND POSSIBLE ACTION OF THE FY19 DRAFT UNIFIED PLANNING WORK PROGRAM (UPWP)

Chris Bridges, CYMPO Administrator (Task #101)

Mr. Bridges explained timeline for approval of the FY19 UPWP. Explained possibility of funding new Transit Implementation Plan. Expects updated study to cost \$150,000 to \$175,000. Explained that changes can be made prior to the Federal review. If approved, the study would be advertised in early Fall. Chairman Brown suggested revisiting the topic in April as action item to approve. Member Nolan suggested to wait to see what changes occur with state legislation regarding transportation funding. Mr. Bridges confirmed that the CYMPO Technical Advisory Committee will discuss an updated Transit Implementation Plan in April.

# 9. REVIEW, DISCUSSION AND POSSIBLE ACTION OF THE 2019-2028 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM (MTIP)

Chris Bridges, CYMPO Administrator (Task #200)

Mr. Bridges explained CYMPO's goal to keep needed projects on radar and advance projects as best possible with given funding. Reviewed projects currently listed on Draft 2019-2028 MTIP. Member Stump recommended placing funds into interim improvement projects instead of studies. Chairman Brown explained potential for increased funding of Distracted Driving Education efforts if state legislature is modified.

Mr. Davis expressed desire to see money used for leveraging rather than for smaller projects and suggested continuing to lobby and advocate at state level for larger projects.

Chairman Brown explained no additional funding from the state is anticipated in the future. Member Stump explained organizations are no longer allowed to use federal funding on projects and shelf them. Local money has to be used for designs. Mr. Davis advocated for benefits of having project studies completed in the instance that funding becomes available state or federal levels.

Member Stump suggested including improvements on SR 169 into the 2019-2028 MTIP.

Board agreed to postpone motion until April.

Ms. Stotler presented ADOT's request for updated transit providers list to the Coordinated Public Transit – Human Services Transportation Plan for Yavapai County.
