#### 4. **PRESENTATION BY GAME AND FISH**

#### (Scott Sprague, Game and Fish)

Mr. Sprague, with Game and Fish, provided presentation on effects of transportation on wildlife and habitats. Explained that changes in habitats affect gene flow of species. Explained costs associated with wildlife/vehicle collisions. Reviewed methods for mitigating wildlife/vehicle collisions.

Mr. Sprague presented Member Greenberg with the Arizona Chapter of Wildlife Society Conservation Award.

# 5. DISCUSSION AND REVIEW OF WILDLIFE MITIGATION LEGISLATION, METHODS, AND TOOLS

Member Budinger provided presentation on regulations set in place by Federal Highways regarding efforts to mitigate hazards caused by wildlife. Explained that in order for efforts to mitigate wildlife hazards to proceed, plans must be included in the Long Range Plan. Discussed possible funding sources in lieu of expected cuts to federal expansion dollars.
