## 4. PRESENTATION OF AZGEO CHANGE REQUEST TOOL AND STATEWIDE TRAFFIC COUNT PROJECT

The ADOT Geographic Information Systems/HPMS team provided presentation to the TAC of the AZGEO Change Request Tool and Statewide Traffic Count project.

# 5. REVIEW, DISCUSSION AND POSSIBLE ACTION TO RECOMMEND APPROVAL OF REQUEST FOR PROPOSALS FOR REGIONAL ADAPTIVE SIGNAL CONTROL TECHNOLOGY (ASCT) IMPLEMENTATION AND DEPLOYMENT PLAN

Mr. Harmonick provided explanation of the draft Request for Proposals (RFP) and noted that revisions were made to better clarify that this is a planning study. Mr. Bridges reviewed the draft document in detail.

Member Wennes questioned if perhaps the project encompassed too large of an area. Mr. Bridges confirmed that feedback he has received has not indicated that the size of the project is too large, but noted that a portion of the Willow Creek/ Miller Valley Road/ Grove Avenue could be removed from the scope of work if needed.

Member Mattingly noted that while there is a benefit to extending the scope to include the four signals between Whipple Street and Gurley Street, if the TAC sees benefit to the project by omitting those signals, the City would be willing to remove those signals from the scope. John Litteer, with the ADOT Northwest District, noted the potential benefit for including the four signals and seeing what responses are provided by consultants.

Mr. Litteer requested clarification on whether a hired vendor would operate the installed software, or if the responsibility would fall to the local agencies. Mr. Litteer noted that this type of system would likely require continual operational maintenance. Mr. Bridges explained there is the option to do it either way and that projects similar to this utilized a Traffic Operations Center that would oversee the continued operations throughout all involved jurisdictions. Mr. Bridges noted that a regional Traffic Operations Center does not currently exist in the CYMPO region. Also explained that the RFP is requesting guidance on the best way to implement continued operations and maintenance and could potentially identify training opportunities to provide to staff at local agencies.

Mr. Litteer requested clarification on the traffic counts and projections that would be required and noted that current traffic does not reflect normal counts due to current conditions resulting from COVID-19.

Member Davis noted the latest traffic counts available for the Town of Prescott Valley are from 2017 and suggested that verbiage in the RFP be modified to request most recent traffic count data instead of requiring data from the last two years. Member Mattingly noted that in recent conversations with consultants, it was mentioned that they may use the data they can access through Streetlight Data. Mr. Litteer suggested modifying the verbiage to indicate that the consultant will identify the data most appropriate to utilize for the analysis.

Member Davis suggested including a task for public involvement in the RFP. Also suggested that a Working Group meeting be scheduled for review of responses to RFP.

#### MOTION

Vice-Chair Marbury motioned to recommend approval to recommend advertisement of Request for Proposals for Regional Adaptive Signal Control Technology (ASCT) Assessment of Need, Benefit and Implementation with noted changes from today's discussion. Member Mattingly seconded the motion.

The vote on the motion was unanimous.
