## 4. REVIEW, DISCUSSION AND POSSIBLE ACTION TO RECOMMEND APPROVAL OF CONSULTANT SELECTION FOR THE REGIONAL ADAPTIVE SIGNAL CONTROL TECHNOLOGY (ASCT) IMPLEMENTATION AND DEPLOYMENT PLAN

Mr. Bridges noted that the submittals were competitive, and that the highest scoring firm was Burgess & Niple.

### **MOTION**

Member Davis motioned to recommend approval to select Burgess & Niple as consultant for the Regional Adaptive Signal Control Technology (ASCT) Implementation and Deployment Plan, and to select AECOM Technical Services, Inc. as runner up. Member Mattingly seconded the motion.

## 5. REVIEW, DISCUSSION AND POSSIBLE ACTION TO RECOMMEND APPROVAL OF REQUEST FOR QUOTES FOR SR89/ SR89A EASTBOUND ON-RAMP ALTERNATIVE SELECTION REPORT

Daniel Harmonick, CYMPO Transportation Planner (Task #200)

Member Davis requested confirmation that the SR89 to Robert Road Transportation Study performed by AECOM in 2018 will be referenced in the Request for Qualifications (RFQ). Member Davis also inquired if the Initial Report referenced in the RFQ will require review from only the TAC, or if ADOT and FHWA are involved. Suggested that the Initial Report be reviewed by ADOT to ensure it meets all requirements and then to have TAC review afterwards. Member Litteer clarified that this type of study would also be included in ADOT's design review. Noted that a study such as this would typically take roughly 3 to 4 weeks for review.

Mr. Bridges noted that changes will be made to clarify timeline for Initial Report. Also noted modifications being made to change reference of "dual on-ramp" to "additional lane", to reference the previously completed SR89 to Robert Road Transportation Study performed in 2018, and to change scoring method from percentages to points. Mr. Bridges noted that due dates will be modified to reflect postponing advertisement until January 2021.

### **MOTION**

Member Davis motioned to table the advertisement of Request for Quotes for the SR89/SR89A Eastbound On-ramp Alternative Selection Report until after January 1<sup>st</sup>, with noted changes as discussed today. Member Hanks seconded the motion.
