# 8. REVIEW AND DISCUSSION OF THE SCOPE OF WORK FOR THE SUNDOG CONNECTOR DESIGN CONCEPT REPORT AND ENVIRONMENTAL OVERVEIW

Daniel Harmonick, CYMPO Transportation Planner (Task #200)

Mr. Harmonick explained that the Request for Proposals for the Sundog Connector Design Concept Report and Environmental Over is anticipated to advertise in November, and work to begin in early March 2022.

Member Greenberg inquired if the concerns of the EMAC will be forwarded to the CYMPO Executive Board. Mr. Harmonick explained that any recommendations from the EMAC will be forwarded to the Technical Advisory Committee (TAC), by the TAC liaison, to be considered for recommendation to the Executive Board.

Dan Cherry, Yavapai County Public Works Director and TAC Liaison for the EMAC, clarified that EMAC members may provide comments to the Executive Board as citizens, outside of the EMAC, during the call to public.

Member of the public, Barbara Jacobsen, inquired about why CYMPO is looking to hold off on a public meeting for the Sundog Connector project. Also expressed concern about EMAC's inclusion in the process.

Madam Chair DeWitt explained that the EMAC is currently reviewing a draft scope of work for a planning study that will begin in early 2022. Mr. Harmonick explained the scope of work being presented today is for a planning study to provide a 15% design plan for the Sundog Connector project, and staff is seeking any recommended changes to the scope from the EMAC.

Mr. Gallegos explained that the public will have several opportunities to provide comments over the course of the design phase of the project, which could take several years.

Mr. Cherry inquired if a wildlife corridor has been identified in the area of the proposed project. Vice-Chair Johnston requested a shape file to be able to research potential existing wildlife corridors.

Member Budinger suggested adding language to evaluate previous studies.

Member of the public, Barbara Jacobsen, suggested including more specific requests.

Mr. Cherry suggested including the collection of additional data as needed. Vice-Chair Johnston noted she will consult with Arizona Game and Fish staff to identify data that has already been collected.

Mr. Litteer, ADOT Northwest District Senior Transportation Engineer and CYMPO TAC member, noted the scope of this project may be useful in identifying a more detailed scope of work for the next phase of design.

Member Budinger summarized the EMAC's recommendation to include language to review and incorporate past studies and evaluate and coordinate new data collection.
