## 4. ANNOUNCEMENTS AND UPDATES

Ms. Post announced that staff is preparing to conduct an Active Transportation Plan.

#### 5. CYMPO UPDATES

Vincent Gallegos, CYMPO Executive Director (Task #100)

Mr. Gallegos announced that, through the Rural Transportation Advocacy Council (RTAC) funding initiative for transportation funding in Greater Arizona, CYMPO is receiving \$3 million for improvements to the SR89 to SR89A On-Ramps. Noted that the estimated total project cost is \$5.5 million, and explained that ADOT may contribute District Minor Funds to fund the additional \$2.5 million needed.

Mr. Gallegos also announced that CYMPO is receiving \$1.5 million to contribute to a roundabout at the intersection of SR69 and SR169. Noted that ADOT is managing the project and contributing over \$3 million to the project.

Mr. Gallegos also announced that Bryn Stotler will be rejoining CYMPO staff as a Planner on June 30th.

# 6. CONSIDERATION AND POSSIBLE ACTION TO APPROVE THE APRIL 25, 2022 MEETING MINUTES OF THE EMAC

### **MOTION**

Member Greenberg motioned to approve the April 25<sup>th</sup>, 2022 meeting minutes of the EMAC. Member Budinger seconded the motion.

## 7. REVIEW, DISCUSSION, AND POSSIBLE ACTION TO RECOMMEND APPROVAL OF RESOLUTION #2022-02 FOR PRESERVATION OF OPEN SPACE ON GLASSFORD HILL

Lindsay Post, CYMPO Transportation Planner (Task #100)

Ms. Post presented the draft resolution to the EMAC. Member Greenberg requested that the resolution reflect EMAC's support for the preservation of open space beginning in April. Mr. Cherry suggested adding reference to the Intergovernmental Agreement between the Town of Prescott Valley, City of Prescott, and Yavapai County to the resolution.

Member Budinger suggested additional language to be included. Member Greenberg noted that the EMAC's support of the purchase of open space on Glassford Hill Road is unique in its focus on the preservation of wildlife habitat and connectivity.

### **MOTION**

Member Budinger motioned to recommend approval of Resolution #2022-02. Member Greenberg seconded the motion.

# 8. REVIEW AND DISCUSSION OF THE SUNDOG CONNECTOR DESIGN CONCEPT REPORT AND ENVIRONMENTAL OVERVEIW PROJECT

Lindsay Post, CYMPO Transportation Planner (Task #200)

Ms. Post presented the Sundog Connector webpage, and reviewed the project timeline. Also reviewed questions posed to those who attended the Stakeholder meeting held in June. Mr. Gallegos requested that EMAC members forward any comments from the public to CYMPO to be considered during the project. Member Greenberg noted that it would be beneficial to educate the public on the process and timeline of road projects.

Member Greenberg also suggested stating on the Sundog Connector webpage that the EMAC will be actively involved in the planning process. Madam Chair DeWitt noted that in order for comments to be properly handled, public comments related to the Sundog Connector Design Concept Report and Environmental Overview (DCR & EO) should be provided during the scheduled Stakeholder Meetings and Public Outreach Meetings rather than at EMAC meetings.

Ms. Post read a comment provided by Joanne Oellers, "I suggest expanding the Facebook page instead of engaging in Nextdoor. Isn't AECOM doing outreach?". Ms. Post replied, yes AECOM is developing a Public Involvement Plan for the project. Mr. Cherry noted that the email distribution is a good method for members of the public to receive information regarding the project.

### 9. REVIEW AND DISCUSSION OF THE SR69 URBANIZED CORRIDOR MASTER PLAN

Vincent Gallegos, CYMPO Executive Director Lindsay Post, CYMPO Transportation Planner (Task #200)

Mr. Gallegos explained that the SR69 Urbanized Corridor Master Plan is the next project in line in CYMPO Transportation Improvement Program, following the Sundog Connector DCR & EO. Also explained that it is the goal of CYMPO to have both the Sundog Connector DCR & EO and SR69 Urbanized Corridor Master Plan completed around the same time in order to provide decision makers with the most information when considering both projects.

Mr. Gallegos noted that the SR69 Master Plan will stretch 15.5 miles from SR89 to the intersection of SR169. Noted that the intent of the study is to identify innovative improvements to safety and capacity, taking into consideration restrictions related to land and funding. Mr. Gallegos provided an example noting that the one mile widening project taking place on SR69 between Prescott Lakes Parkway and Frontier Village has been in the works for 8 years at a cost of \$13 million.

Ms. Post reviewed the project solicitation schedule and scope of work. Noted that a goal for the project is to produce a list of prioritized segments that can be improved throughout the SR69 corridor.

# 10. REVIEW, DISCUSSION, AND POSSIBLE ACTION REGARDING THE PURSUIT OF FUNDING FOR THE INFRASTRUCTURE INVESTMENT AND JOBS ACT (IIJA)

Lindsay Post, CYMPO Transportation Planner (Task #100)

Ms. Post briefly reviewed language from the Bipartisan Infrastructure Law (BIL) regarding initiatives for wildlife crossings and wildlife collisions.

Member Budinger noted that CYMPO would be eligible to receive a grant under a pilot program, and suggested that such funding may be helpful in collecting information related to wildlife migrations in areas of planned CYMPO projects.

Mr. Cherry explained that it is important to establish a historical process, through planning efforts, to be in a good position to pursue for federal funding.
