Senator Kelly and CYMPO Successful with \$480K Award

Central Yavapai Metropolitan Planning Organization (CYMPO) staff was successful in our application for Congressionally Directed Spending funding from Senator Mark Kelly. \$480K was apportioned for the upcoming State Route 89A Design Concept Report (DCR) and Environmental Overview (EO) project. This DCR will help prepare SR89A between SR89 and Glassford Hill Road to be widened from 4 lanes to 6 lanes to better support regional growth.

CYMPO has been working to improve the SR89 and SR89A interchange by adding an additional east bound on-ramp lane with design and construction beginning in the next year. CYMPO has worked with the Arizona State Legislature to secure \$3M for this \$5.5M project.

We are proud of the work we have done throughout the region and now in this corridor. This is a great way to begin the new year!

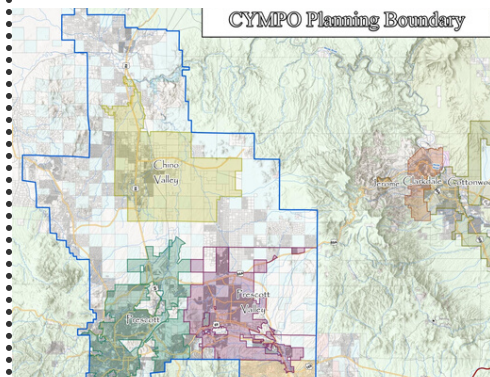


Vision:

CYMPO will soon initiate the **Central Yavapai Active Transportation Plan**, to be known as ACT-UP: Active Community Transportation – Unified Plan. The purpose of the project is to identify a regional network for alternative transportation modes (bicycle/pedestrian) to connect to vital services and transportation facilities.

The **Regional Strategic Transportation Safety Plan (RSTSP)** update is underway. The purpose of the RSTSP is to address safety from a holistic, regional perspective to reduce the risk of death and serious injury to all transportation users. The plan will deliver achievable safety solutions for all modes of transportation.

The **Sundog Connector Design Concept Report** project is underway with consulting staff currently developing the draft design alternatives for presentation to stakeholders and the public. The study area is located on Glassford Hill which includes Prescott, Prescott Valley, and Yavapai County For more information, visit www.cympo.org/sundog-connector/

The **SR 69 Urbanized Corridor Master Plan** has just begun and is scheduled for 12 months. We anticipate this plan commencing at the end of 2023. The goals for this project are to evaluate traffic, safety, design solutions and more between Prescott and Dewey-Humboldt.
